Dear Colleagues,

We are currently collecting campus spend data on a quarterly basis for the Corporate Spend Program (CSP). The data submissions require refinement and cleansing of the vendor names to aggregate spend for system-wide commodity analysis. Data cleansing will be provided by CVM Solutions and allow UC to augment CSP data with business classification and DUNS information. To this end, the Materiel Managers have agreed that the following fields will be added to the data submitted quarterly:

UC will compile the data and send it to CVM. CVM will cleanse the data and return the data to UC for uploading into the Corporate Data Warehouse.
