**Significant events:** At 3:00 p.m. yesterday, all Evacuation Orders and Warnings were lifted for the Harris Fire. The previously evacuated areas are open to residents only. Firing operations were successful along Wilson Creek. Direct line construction will continue in Hauser Canyon near Barrett Lake.

The Harris Incident has been notified by the United States Forest Service (USFS) that the Cleveland National Forest is closed until further notice. The USFS recognizes that deer hunting season has begun, but due to the ongoing fire emergency in the Cleveland National Forest, it is not safe to allow anyone into the area. The forest will be closed until further notice.
